There will be a \$15.00 fee for each additional day that the dumpster remains on site past the contract term, so long as the dumpster is available and not needed to fulfill another order.

Your dumpster allows for \_\_\_\_ tons of debris disposal. Each additional ton over this limit will incur a \$40.00 fee (prorated per ton).

The rental charge for this contract term is \$\_\_\_\_\_ + tax as agreed upon prior to delivery. This rental charge includes one dump per contract term. There will be a fee of \$\_\_\_\_\_ + tax for each additional dump in the contract term.

There will be a \$75.00 fee to relocate the dumpster on the property after the initial placement.

Dumpsters can only be filled to the top of the dumpster. There are no exceptions. Any items protruding from the top of the dumpster will be removed at pickup and it is the customers responsibility to dispose of those items.

Full payment is expected prior to delivery. We accept cash, Visa, MasterCard, Discover, and American Express.

On the day of pick up, Ohio Dumpster Rentals will attempt to make a courtesy call prior to arrival. If the dumpster is inaccessible in any way (DO NOT BLOCK DUMPSTER), a \$150.00 fee will apply.

We accept most construction debris and residential or commercial waste from clean outs.

If any of the non-accepted items are found in the dumpster after customer use, customer will be charged a \$500 fee. I acknowledge \_\_\_\_\_.

Customer agrees to indemnify, defend and hold harmless Ohio Dumpster Rentals, including its members, employees, agents, and affiliates from and against any and all claims, counterclaims, fines, penalties, expense, charges, suits, demands, actions, damages and any other liabilities of any kind and nature asserted or alleged by any third-party arising from the dumpster rental, storage of prohibited substances, Customer's failure to obtain or maintain any required permits, loss or theft of the dumpster, personal injury and/or property damage related to Customer's use or possession of the dumpster, and physical damage to the surface used to place the dumpster.
